The 2018-2019 Math Contest team scored a record breaking 131 points over six contests. This great score garnered the team a 20th place State finish among all schools in Ohio (regardless of size). The team also placed 2nd in the region behind Avon Lake, beating traditional powerhouse Mentor by 6 points! Sam Delatore was the State Champion, achieving a perfect score of 36 points. Team scorers included Tyler Berry, Diego Calderon, Gabriella Calderon, Matt Commons, Megan Delaney, Sam Delatore, Alex Diiani, Avery Doctor, Margaret Faur, Mum Masaki, Ethan McKenzie, Ashlin Rabindra, Andrew Testa, Collin Todd, & Jared Tucker.

Sam Delatore also qualified for the prestigious American Invitational Mathematics Exam, and placed high enough there to participate in the USA Mathematical Olympiad. Only the top 270 students in the United States qualify for the USA Mathematical Olympiad, and Sam qualified all four years of his High School career.
